AGENDA TOPICS

1. Topic Facilitator Welcome | Presenter Glenn Starr

Welcome: Glenn Starr opened meeting, welcomed all and asked that every attendee ensure they sign the Attendance Register. Apologies were then read out.

Previous Meeting Minutes: Minutes of the previous meeting introduced by Glenn Starr. No questions about the minutes. Glenn Starr requested that a resolution be passed confirming the previous 2016 meeting minutes are an accurate record of the previous meeting.

2. Topic Presidents Report | Presenter Glenn Starr

Discussion: Glenn Starr (GS) provided a report on this years activity:

- GS advised that this year was the best we have seen for at least a decade
- The club won the 2016 Junior Incentive Award, Coach of the Year Award (Mick Withers), and was a finalist with Player of the Year (Tyler Field) and Club of the Year at the recent Parramatta JRL Awards night
- One of the reasons for success is that our coaching and players development is improving with the initiatives we are running like the Bulls Academy
- The Club has acquired the 'Hills Bulls Sports Club' name and has developed new branding/logos
- GS advised that this year was the best year to date regarding Sponsorship for both Junior & Senior RL
- Oztag is still going from strength to strength with both the social competitions and our Rep Squad
- GS introduced the Governance Manual which he said will only be beneficial to the Club and this will be discussed further in Special Business
- We currently have a great relationship with Parramatta JRL and the Hills Shire Council, and have continued good rapport with Australian/NSW OzTag

• GS also mentioned that our Senior Footy this year was very competitive, and is continuing to do very well and as per the financials was self-funded this year.

3. Topic BOM/Committee Reports | Presenter BOM

Discussion: Michael Gremmo (MG) gave an overview of the council and clubhouse/grounds matters:

- MG advised that we are still waiting on the council to meet (Council Meeting 21/11/17) to discuss options of what they do for us with the clubhouse. ie. Leave it as is, Just complete current building or Build 2nd Floor. We will then know what they will provide and what the Club needs to do moving forward.
- We are also waiting on the Council to meet to approve \$150k improvements for bottom oval.
 - Steve Marks asked if the bottom oval would be a Mini or Mod field MG advised that due to the boundary from the creek bank being 20 Mtrs there will be enough area for 2 x training fields/2 x OzTag fields

Discussion: Greig Newbery (GN) gave an overview of OzTag matters:

- GN advised that a new Online Registration system was introduced this season with all team/player rego payments being paid online. While there has been a few teething issues, the online system has worked very well with the majority of payments coming through online reducing the amount of days volunteers needed to be at club taking regos and handling cash.
- GN advised that the 2017 association competition was another strong year with competitions running over 4 nights a week:
 - Mon U16 Boys/Mens Open
 - Tue U16 Mixed/Mixed Open
 - Wed U10/U12/U14 Boys overflow from Friday
 - Fri All Juniors using 11 fields (Crestwood F1, F2, F3 & Basin) over 7 time slots
- GN gave a brief explanation on the Registration costs and what the comparison is with other clubs
- GN advised that we have Rep teams in every age group for the 2018 State Cup, and we also looking at putting in a Mens Open & Mixed Open team.

Discussion: Scott Chalcraft (SC) gave an overview of Marketing matters:

- SC introduced the family of new Logos/Branding and gave an overview of the website. The new logos are to assist with the clubs identity and branding ensuring all the clubs functions and sports are identified in a united brand.
- SC advised that the new logos are being gradually introduced.
- GS advised that all the new branding and Hills Bulls Sports Club is owned and managed by Hills District JRLFC&TA Inc.
 - John Abbott asked if the new Logo and Hills Bulls Sports Club would create a problem with voting and possible takeovers
 - Martin Shanahan advised that as long as the Club's constitution is worded correctly and strong
 enough to maintain a majority of HDJRLFC votes Majority of the Board should always have at
 least 4 of the minimum 7 BOM members being from the Rugby League club.
- SC advised that we are looking at consolidating the Clubs Socials media sites to stop confusion and ensure we have control on content
- SC also advised that this year we have greatly increased our Club/Brand exposure through building relationships through both local newspapers with stories produced most weeks.

4. Topic Annual Financial Report FY1617 | Presenter Joanne McCauley

Discussion: Mark Mahoney (MM) introduced Joanne McCauley (Club Accountant/Auditor) who gave an overview of the finances for the club. Financial statements for the year ended 31 August 2017 prepared by Jigsaw Tax Accountants was provided to all attendees and tabled at the meeting.

Joanne read through the financial report raising the following points:

- The Clubhouse renovations have been amortised over 10 years with the first stage at 10%.
- Recommended that the New BOM review Old Account Receivables and advise what needs to be written off.
- GST differences have now been resolved and is up to date.
- MYOB software had been updated and is now on the Cloud, and working well.
- Commended the Board for good governance practises and taking on the recommendations for monitoring budgets at monthly meetings.

Joanne from Jigsaw Tax then went through the audit report financials. Stated she audited the accounts as they were presented to her. Jo stated she is independent with no children playing at the club.

The surplus for the financial year amounted to \$113,483.
